SESSION #1:



CHRIS JAHN, AIA; Senior Associate, Education Studio at SWBR

Chris Jahn, AIA, is a Senior Associate in the Education Studio at SWBR. Licensed in 2005, Chris has spent most of his career designing and managing projects for colleges and universities. His work spans 15 campuses and ranges from small renovations to new buildings, including several non-gender-specific restroom facilities. Through this experience, Chris has gained a deep understanding of the critical factors influencing restroom design — including code requirements, societal influences, and economic factors. Chris earned a Master of Architecture and a Master of Sciences in Civil Engineering / CM from the University of Illinois in 1999.

DANIEL ABRAHAMSON, CEM; Energy Manager, Operations and Services; Facilities Management, University of Massachusetts Lowell

Dan Abrahamson is the Energy Manager for the University of Massachusetts Lowell. As part of the Facilities Operations and Services team, Dan helps manage the University's \$11 million utility budget through energy efficiency and demand management initiatives. In addition, Dan works to build the campus's alternative energy portfolio to achieve the goals of UML's Climate Action Plan.

Since 2019, he has helped the University generate over \$3 million in capital and demand response incentives and developed programs to continually re-invest funding towards strengthening UML's cost savings, emission reductions, and resiliency efforts. He is active within the Commonwealth's Energy Intelligence program and oversees the University's Enterprise Energy Management platform that records and delivers data for over 4 million square feet of building space. Most recently, Dan managed and collaborated on the University's Alternative Energy and Carbon Mitigation Masterplan to strategize an effective path towards realizing Massachusetts' Executive Order 594 goal of net-zero by 2050.

Prior to UMass Lowell, Dan worked at the Massachusetts Bay Transportation Authority as an Energy Specialist where he launched a \$40 million energy efficiency program established to help reduce the MBTA's operating costs by \$2.7 million a year.

Dan received his B.S. in Construction from the University of Massachusetts Amherst. He is currently a Certified Energy Manager through the Association of Energy Engineers. His experience includes PMP, LEED, ENV Sustainability Professional, Energy Star, and BPI



ZACK HALLOCK, Senior Energy Services Advisor, Competitive Energy Services

Zack Hallock joined CES in January of 2019 as an Energy Services Advisor and was promoted to Senior Energy Services Advisor in 2022. Prior to CES, Zack worked with major utilities on large scale transmission and midstream operations to provide appropriate staffing services. Currently, Zack closely advises demand side management and procurement strategies, budgeting, variance tracking, and various forms of renewables integration into an energy portfolio. He has a B.A. in Economics and Environmental Studies from St. Lawrence University and is also a LEED Green Associate.
